Single Room Fee	\$3201	Creekview Apts. Single Room Fee - \$3345, College Creek Apts. Single Room Fee - \$3515
Double Room Fee	\$2586	Creekview Apts. Double Room Fee - \$2703, College Creek Apts. Double Room Fee - \$2838
Triple Room Fee	\$1774	Triple rooms available in the Canyon or the Hill.
Board Fee	Varies	Meal Plan mandatory except for those residents assigned to Creekview, Campus Apartments or College Creek. Meal plan costs are: Green - \$1938, Gold - \$2288, Humboldt - \$2638 and Mini - \$938.
Security Deposit	\$100	Mandatory - refundable as prescribed in Housing License.
Service Fee	\$5	Charge per payment up to maximum of \$15 unless fees for entire Spring 2012 Semester are paid in full by January 10, 2012.
Activity Fee	\$15	Residence Hall Government Association activity fee.
Late Fee	\$10	Payments received 5 days after due date are subject to this late fee.
Miscellaneous Fees	Vary	For such items as replacement keys, safety and maintenance, borrowed items damaged or not returned.
OACS Fee	\$137.50	Non-refundable fee for Outdoor Adventure and Community Service (OACS) living area - for Alder residents only.
Penalty Fees	Vary	Assessed for canceling during the fee period, requesting to vacate or charged to those whose license is revoked for disciplinary reasons. Penalties vary and can equal the total academic year housing and dining fees.
Returned Check Fee	\$25	Assessed against all returned checks regardless of cause and is non-refundable.
License Cancellation Fee	\$200	Minimum charge for cancellation of license, regardless of room assignment status. If you cancel in writing with the Housing Office prior to January 2, 2012, you will be charged a cancellation fee of \$200. If you cancel between January 2 - January 9, 2012 you will be charged the \$200 cancellation fee and a prorated penalty fee for each day of notice which is less than the required 30 days. Beginning January 10, 2012, cancellations are no longer valid and students will be held financially responsible for their housing contract. The cancellation fee and prorated penalties are only waived if we are unable to offer licensee a room as of January 10, 2012. Please read the license agreement for specific details.
