### **Important Information Regarding Disbursement of Financial Aid Funds**

Funds will not disburse until all conditions for admission to the university have been satisfied. Please check with the Office of the Registrar at 707-826-4101 if you have been provisionally admitted.

Once all disbursement requirements have been met, financial aid funds are disbursed by crediting your student account. Your financial aid will automatically pay toward current academic year charges for fees, tuition and on-campus room and board.

Student Financial Services will mail your check to your local mailing address as shown on the university computer system. It will not be forwarded by the U.S. Post Office. Therefore, it is very important that you keep your mailing address and your email address updated on the Web Information System should changes occur.
