 - i. Mike Fisher discussed the foreseeable vacated spaces in Harry Griffith Hall and Natural Resources buildings that will result from moves relative to new space in Engineering & Technology, as well as new vacated space in Little Apartments related to SBDC's move to StartUp Humboldt. Additionally, the Science A renovation project design has started and when the renovations are under construction, there will be a need for temporary flex space.

 - i. [SAMO 112](#) initial proposal to change allocation from Undefined, Temporarily Offline to the Office of Sponsored Programs related to Vero line lease between USGS and Sponsored Programs. This program is a federally funded three-year program (at least). The discussion evolved into the purpose of the space, which is telecommunications, therefore the committee agreed that the allocation should be to ITS - Telecom and not the Office of Sponsored Programs.
