iv. Review and vote on Solitary Garden proposed by Project Rebound. The proposal includes solitary garden 6'x9' in size to be used as a meditative space located at the former Jensen House footprint, north of G14 parking lot.



1. Ann Johnson-Cruz asked if it was an art installation meant to be viewed from the outside, or is it meant to be experienced inside? If inside, it would likely need a new location and accessible access. Kristen Gould indicated that clarification on the purpose is important. Is it meant to be in an open/exposed location, or is the goal to be more private and contemplative? The location to the north of Nelson Hall East might be ideal if it's meant to be private. Jim Woglom indicated that PAWG will take these questions back to Project Rebound to discuss and refine the proposal. Dave Jannetta questioned the longevity of the materials, and that it might appear to be unfinished once installed.
