Housing License Agreement  
License Terms and Conditions 2026-2027  
Two-Year Housing Requirement Addendum**

Refer to the Cal Poly Humboldt Housing License Agreement 2026-2027. By completing and signing the Housing License Agreement, you agree to all of its provisions. Please read these provisions carefully before submitting a completed License Agreement and Two-Year Housing Requirement Addendum.

This addendum to the License Agreement presents the Terms and Conditions by which a Cal Poly Humboldt student agrees to abide as part of the Two-Year Housing Requirement, which requires living in university housing for the 2026-2027 and 2027-2028 Academic Years. This addendum is incorporated into and supplements the Cal Poly Humboldt Housing License Agreement. Except as stated in this addendum, it does not alter any conditions or obligations in the License Agreement.

This addendum is effective for two full academic years, covering both fall and spring semesters, or for such portion of the academic year(s) remaining, when the License Agreement is signed for first-time students who matriculate to Cal Poly Humboldt. In addition to the License Agreement, the following will apply:

**I. License Agreement Contract Period**

- a) The agreement and fee period extend over two consecutive academic years.
- b) The License Agreement period for the second academic year 2027-2028 begins on August 16, 2027, and ends on May 13, 2028. Dates are subject to change based on the approved academic calendar.
- c) Exemptions for the housing requirement can be requested. Process and deadlines need to be followed. The Housing Exemption information can be found at: <https://www.humboldt.edu/housing-reslife/housing-exemption>

**II. Fees**

- a) The Licensee acknowledges that during the term of this agreement, room and meal plan rates are subject to change annually at the start of a new academic year at the sole discretion of the university. These rates are subject to change, but not to exceed a 9% increase on approved 2026-2027 rates. Notice of changes in fees or services will be provided to the Licensee no later than spring 2027.

- b) If a First-Year Student accepts admission to the University and does not sign the Housing License Agreement or file for an exemption that is approved, their admission to the University is subject to revocation.
- c) If a Student does not take the steps required to complete their Housing Application for their second required year, University Housing will automatically assign the Student into an available space and charge the Student Account.

### **III. Meal Plan**

- a) Meal plans are required in all living areas.
- b) Students can sign up for the meal plan of their choice in their Housing Application. Students will be assigned the minimum meal plan required for their assigned living area, should they select a lesser meal plan in their housing application.

### **IV. Room Assignment and Housing Application**

- a) The 2027-2028 Academic Year Housing Application will open in February. Licensee will be given notice via email of the details of the application process.
- b) Licensee is required to fully vacate their space at the end of the Spring 2027 semester per the established dates of the License Agreement. Summer housing options will be made available for those who choose to remain during Summer 2027.
