Last academic year, the committee voted to revise the timeline of the competition to better accommodate academic planning. Previously, the Request for Applications (RFA) was released each fall with a deadline of mid-January. Awards were then announced between February/March for the following year, which typically come after the fall course schedule is already set.

The current academic year's timeline was altered to confirm Incentives awards prior to winter break, and report out at the December Board meeting.

There were a number of unforeseen complications resulting from this change, including: lower participating from faculty applicants, lower participation from review committee members, difficultly scheduling adequate review time, negative feedback from applicants, etc. Discussion ensued.
